"Have a happy birthday." As though I were the only one around, he was walking elegantly in my direction while wearing the most exquisite smile on his angel's face." (Meyer, 2006:7)

On her eighteenth birthday, during a party hosted by the Cullens, an accident involving a paper cut leads to a dangerous situation where Edward's brother, Jasper, nearly attacks her. Bella's attraction to Edward is sparked by his mysterious demeanor and striking appearance, in line with Cawelti's idea of physical attraction as the basis for romantic relationships. the initial attraction between Bella and Edward in New Moon is portrayed

Cawelti's theory suggests that such dependencies can lead to imbalances in romantic relationships, where one partner's well-being is too

This separation highlights Bella's emotional struggles and deepens her sense of identity crisis. The inherent differences between their worlds pose a constant challenge. Despite the supernatural obstacles and dangers they face, their love persists and deepens, reflecting a cultural fascination with enduring romantic bonds.
