Literary work is one the ways that a person uses to express ideas, thoughts, and feelings in the form of a work that is represented aesthetically. Nowadays, there are many issues regarding gender inequality that occur in society. This is one of the problems for women regarding rights that are not obtained as women. This study discusses the Mulan (2020) movie which was released on 9th March 2020 where the movie shows the reality of life that adheres to a patriarchal ideology in which women are considered weak. This research aims to determine the representation of gender inequality in Mulan (2020) movie which uses descriptive qualitative research method and feminism approach. Gender inequality is shown through 4 indicators, limited opportunities in utilizing resources, limited opportunities to participate in an activity, limited authority in making decisions, and limited recognition in decision making. The representation of gender inequality can be seen through the characters, setting, events, and style. The reason of Niki Caro addressing gender inequality in the Mulan (2020) movie is found in the personal life of the director where the director is an activist for women's rights.

The first research that is relevant to this research is the research by Sirikit A. #### c. Battlefield

The existence of regulation regarding gender causes Mulan to continue to hide her identity as a woman even though she has done her best for her troops. The military commander is very strict about the regulations that have been made, thus the military commander will not tolerate anyone who violates the rules for any reason. The war took place in a very chaotic manner where each military force defended its troops from being attacked by the enemy. Mulan's ambition to fight enemies causes Mulan's hair to fall down to reveal her true identity as a woman.

## d. The Northern and Southern Dynasties

The Mulan (2020) movie is set during the Northern and Southern Dynasties where the dynasties took place in the 4th to 6th centuries in China. During the Northern and Southern Dynasties in China there was significant gender inequality where at the time women received limitations in the fields of education, employment, and political participation. At the time, women were dominated to do household chores and take care of the family.

One day, Mulan and her mother went to meet a matchmaker. But on the way, Mulan and her mother met several women on their way to the matchmaker's place. This incident supports the notion that gender roles are portrayed as tools for sharing societal beliefs that apply to individuals and are based on gender.

# b. Mulan's Meeting with the Matchmaker

Mulan finally met a fairly well-known matchmaker in her village who was going to set her up with several men. In Grandma Fa's room, there were several women who told Mulan the specific criteria to achieve the perfect wife in the future. So, Mulan must have special criteria to create a good household, including good taste, calmness, obedience, working fast, developing well, and having a small waist. From this incident, it can be explained that gender roles are the result of interactions between an individual and the environment around him.

# c. Women's Explanation regarding the Differences in the Roles of Men and Women

In Grandma Fa's room, there were several women in the room explaining the different roles between men and women in serving a country.

Meanwhile, women are different from men in that women have to give birth to children and then care for them. But as a daughter, Mulan doesn't only serve her father, she must also prepare herself to be a good woman for her husband.

#### d. The Chaos caused by Mulan

Mulan causes chaos in the ceremony with her attitude and behaviour. Mulan covered the spiders falling from the sky with a teapot, but the matchmaker insisted on placing the teapot in the middle of the table. As a matchmaker, Fa's grandmother believes that a woman must have good manners to get a good man, but Mulan is destructive and careless during the ceremony. Mulan disappointed her family, who hoped that she would be the perfect bride. From this event, it can be shown that women's lives are more focused on the family that the wider community.

## e. Arrival of Chinese Soldier to Mulan's Village

Soldiers came to hear the emperor's announcement to send one man from each family to serve in the army. The Fa family has no sons, so Mulan's father decides to leave. However, Mulan forbade her father because she was too old and intended to replace her father, but she received discrimination from royal soldiers where there were differences in treatment between men and women. Thus, there is gender inequality between men and women regarding treatment.

## 4. Through Style

#### a. Tone

Tone is one of the styles in a movie that supports the feeling or mood in the movie. The tones in the Mulan (2020) movie are divided into four parts, namely white, blue, red, and orange. The white tone in the movie shows humility, peace, serenity, innocence, snow, and kindness. Then the second tone is blue, this tone gives an image of loyalty, confidence, harmony, unity, trust, stability, etc. Furthermore, the red tone indicates strength, speed, war, power, greatness, passion, etc. And finally, the orange tone shows the embodiment of a symbol of self-confidence, adventure, enthusiasm, balance, and persistence.

#### b. Sound Effect

Sound effects have an important role in a movie. There is one of the most prominent pieces of music in this movie, namely Reflection sung by Christina Aguilera. This "reflection" provides an expression of Mulan's feeling about her desire to show the people

around her and even the world who she really is. Apart from that, there are several sound effects, such as swords, that show the strength on the battlefield shown by Mulan, then another sound effect is the sound effects of animals, such as horses, where the struggles carried out by Mulan are carried out on horseback.

#### C. The Reason of Niki Caro Address Gender Inequality in Mulan (2020) Movie

#### 1. The Director is Women's Right Activist

The director of the Mulan (2020) movie is Niki Caro who is a woman from New Zealand. As a women's director and an activist for women's rights, Niki Caro wants to voice women's rights that should be obtained by women. Through the movie she directed, Niki Caro wanted to show the existence of gender inequality that occurs in the movie industry.

## 2. The Director Wanted to Campaign for Women's Rights

Niki Caro has a desire to campaign for women's rights throughout the world. Niki Caro and Jessica Chastain conducted a campaign on women's rights in 2017 which coincided with the 2017 Women's Parade in Warsaw, Poland. The existence of a campaign on women's rights that Niki Caro participates in and voices shows that Niki Caro pays attention to the phenomenon of gender inequality in her life

There are several studies that are similar to this research because they both examine the Mulan (2020) movie. There is Sirikit A. Usman, Meis Sintia Umar, Mifta Sulistia Tamola. Dan Ridho Ishak (2021), Zhengyang Gong and Yuan Tian (2020), Juli Susanti Br Sinuraya Anang Anas Azhar, and Hasan Sazali (2022). The difference in previous research lies in the topic of discussion. Sirikit A. Usman (2022) analyzes gender equality in terms of Chinese culture. Zhengyang Gong (2022) discusses the struggle for gender equality. Meanwhile, Juli Susanti Br. Sinuraya (2022) discusses the struggle for women's rights. The difference between the three studies and this research lies in the form of perspective analysis of gender inequality in which this study uses John Fiske's theory.

#### **CONCLUSION**

After discussing and analysing the data, the researcher draws conclusion based on the representation of gender inequality in Mulan (2020) movie as follows:

1) There are four indicators of gender inequality in Mulan (2020) movie, which are limited opportunities in utilizing resources, limited opportunities to participate in an activity, limited authority in making decisions, and limited recognition in decision making. In general, gender inequality is caused by an ideology that believes that men are considered stronger than women.

- 2) The representation of gender inequality can be seen through the character, setting, event, and style.
- 3) The reason of Niki Caro addressing gender inequality in the Mulan (2020) movie is found in the personal life of the director where the director is an activist for women's rights who wants to voice that a woman's position is equal to that of a man in any case.

This research analyses the gender inequality in Mulan (2020) movie which contains certain moral values. Therefore, this research is expected to be a reference for other researchers for this research with the same research object. The Mulan (2020) movie has many moral values that are very relevant to everyday life, thus this movie can be a reference for other researchers to analyse with different theories or perspectives.
